Mr. Elliott welcomed everyone to the meeting and thanked the members for their service on the Committee.

Consulting Director's Report: Dan Morrill

Dr. Morrill expressed his appreciation for each member's service on the Committee. He stated that the Commission uses the Secretary of the Interior's Guidelines to determine the appropriateness or inappropriateness of proposed alterations to historic landmarks. Preservation Planner's Report: Stewart Gray

1. Consideration of an Application for Certificate of Appropriateness for Delburg Mill House, 303 Delburg Street, Davidson, N.C.

The applicant is proposing to demolish the existing outbuilding and construct a new garage building.

Staff stated that it believes the proposed new building is appropriate in scale and design and meets the Secretary of the Interior's Standards numbers 2, 9 and 10. The applicant has requested approval for an alternate siding design. Staff believes that the use of both horizontal lap siding on the principal section of the building is more appropriate.

The Committee discussed the Staff proposal at length.

MR. GIESER PRESENTED A MOTION SECONDED BY MR. JONES THAT THE COMMITTEE RECOMMEND TO THE HISTORIC LANDMARKS COMMISSION THAT IT APPROVE THE PLANS AS SHOWN WITH ALTERNATES, THAT THE APPLICANT HAVE THE FLEXIBILITY TO REMOVE THE CHIMNEY, AND THAT THE DESIGN OF THE GARAGE DOOR AND THE FENCE BE SUBMITTED FOR STAFF APPROVAL. THE COMMITTEE UNANIMOUSLY APPROVED THE MOTION.
