## **AGENDA**

## 1. Consideration of Minutes

MR. ERDMAN PRESENTED A MOTION SECONDED BY MR. ELLIOTT THAT THE MINUTES FOR AUGUST 13, 2012, BE APPROVED AS SUBMITTED. THE COMMISSION UNANIMOUSLY APPROVED THE MOTION.

MS. LESTER PRESENTED A MOTION SECONDED BY DR. WEIS THAT THE EXECUTIVE SESSION MINUTES FOR AUGUST 13, 2012, BE APPROVED AS SUBMITTED. THE COMMISSION UNANIMOUSLY APPROVED THE MOTION.

## 2. Chairman's Report: Mr. Asbury

Mr. Asbury welcomed everyone to the meeting.

Mr. Asbury stated that an attendance sheet was at each Commissioner's place for him or her to review.

Mr. Asbury stated that all Commissioners will serve on the same Committees as during the previous year unless they express a desire to do otherwise.

# 3. Director's Report: Dr. Morrill

Dr. Morrill reported the following information:

**a. Dr. George E. Davis House, 301 Campus Street in Charlotte, N.C.** Project Architects continue to prepare final construction drawings. If they comport with approved plans, the Commission will issue a Certificate of Appropriateness, and work will begin.

- **b.** The House at 409 E. Park Ave, Pineville, N.C. Mr. Elliott, Mr. Gray, and Dr. Morrill have met with Mr. Thomas White, the buyer of the house, to review restoration plans. An application for a Certificate of Appropriateness will be considered by the Design Review Committee at its September meeting. Closing on the house is scheduled for September 13, 2012.
- **c.** White Oak Plantation, 7729 Hood Road, Charlotte, N.C. Both the main house and the tenant house continue to be occupied. At its October 18th meeting, the Projects Committee will consider listing the property with a realtor.
- **d. Grier-Rea House, 6701 Providence Road, Charlotte, N.C.** The rezoning petition has been withdrawn in accordance with the Commission's vote at its August meeting. Staff is working with the realtor to market the house for the various purposes allowed under existing zoning. The realtor will be asked to make a presentation to the Projects Committee at its October 18th meeting.
- e. Thrift Depot of the Piedmont and Northern Railroad Company, 8030 Old Mt. Holly Road, Charlotte, N.C. The Technical Coordinating Committee of the Mecklenburg Union Metropolitan Planning Organization will make its final decision on September 13th about amending its Transportation Improvement Plan to include funding for relocating and stabilizing the Thrift Depot. Staff will attend the meeting.
- f. B. D. Funderburk House, 201 West Charles St., Matthews, N.C. Staff has contacted the owner and directed the owner to supply Part One of the Tax Credit Application, so that Staff can ascertain the condition of the house before any renovation work was performed. The owner has agreed to comply.
- **g. Torrence-Lytle School, 302 Holbrooks Rd., Huntersville, N.C.** The Request For Proposals is finished. Staff will be seeking to identify prospective buyers in preparation for their submitting proposals for the redevelopment of the property. The Commission will have to set the asking price.
- h. Rozzel House, 11647 Rozzelles Ferry Rd., Charlotte, N.C. The tenant house has been vacated and is boarded up. Staff will ask the Projects Committee at its October 18th to consider marketing strategies.
- i. McAuley House, 14335 Huntersville-Concord Rd., Huntersville, N.C. The house is being marketed actively, and several showings have occurred within the past month.
- **j. Former Younts General Store, 316 Main St., Pineville, N.C.** Work should begin soon on the repair of the building. At its October 18th meeting, the Projects Committee will consider listing the property with a realtor. The Tenant continues to pay the rent. The renewed lease has been completed.

- **k.** Former Blankenship Oil and Feed Store, 330 Main St. Pineville. At its October 18th meeting, the Projects Committee will consider listing the property with a realtor. The tenant continues to pay the rent. The renewed lease has been completed.
- **I. Preparation of Survey and Research Reports.** Staff is preparing the following Survey and Research Reports: Abernethy House (215 W. Eastway Drive, Charlotte, N.C.), Charlotte Fire Station No. 8 (2009 Commonwealth Avenue, Charlotte, N.C.), Daggy House (102 Hillside Dr., Davidson, N.C.)
- **m. Dr. Bonnie Cone House.** Staff was contacted by representatives of the College Downs neighborhood about prospective historic landmark designation of the home of Dr. Bonnie E. Cone, the former Charlotte College president and the first chancellor of UNCC. Staff explained the process.
- n. McAuley Road Bridge. The State of North Carolina is proposing to replace a one-lane wooden bridge on McAuley Road. Staff met with representatives of the State Historic Preservation Office (SHPO) and the N.C. Department of Transportation. Because the roadway corridor has been declared eligible for listing in the National Register of Historic Places, SHPO will develop a plan that in its judgment meets the Secretary of the Interior's Guidelines. This matter will come before the Commission in the future as an Application for a Certificate of Appropriateness.
- **o. Railroad Track Separation.** Representatives of the N.C. D.O.T. will appear at an upcoming Design Review Committee meeting to explain the plans for separating the CSX and Norfolk Southern Railroad tracks in the area of Elmwood-Pinewood Cemetery.
- **p. Cedar Grove Development.** Representatives of a neighborhood contiguous to the historic landmark have expressed concern about a prospective development. Staff explained that the land on which the neighborhood will be built is not part of the historic landmark.
- **q. Barn Survey.** Alicia Messick has completed a comprehensive survey of barns in Mecklenburg County. County Information Services Technology has agreed to do a demonstration project on the data. Staff hopes to be able to show it to the Survey Committee at its November 1st meeting.
- **r. Preservation North Carolina Conference.** As part of the Commission requirements for continuing education, two Commissioners, John Shurley and Mark Miller, are attending the Preservation North Carolina Conference in Asheville, N.C., September 19-21. Staff recommends that the Commission approve allocating \$150 to each attendee toward expenses.

MR. PURSLEY PRESENTED A MOTION SECONDED BY MS. LESTER THAT THE COMMISSION PAY UP TO \$150 EACH TO MR. MILLER AND MR. SHURLEY TO COVER A PORTION OF THE EXPENSES OF THEIR ATTENDANCE AT THE PRESERVATION NORTH CAROLINA CONFERENCE IN ASHEVILLE, SEPTEMBER

19-21. THE COMMISSION UNANIMOUSLY APPROVED THE MOTION WITH MR. SHURLEY ABSTAINING FROM THE VOTING.
