# **AGENDA**

# 1. Consideration of Minutes

MR. ERDMAN PRESENTED A MOTION SECONDED BY MR. ASBURY THAT THE MINUTES FOR THE AUGUST 12, 2013 MEETING OF THE HISTORIC LANDMARKS COMMISSION BE APPROVED AS DISTRIBUTED. THE COMMISSION UNANIMOUSLY APPROVED THE MOTION.

2. Chairman's Report: Mr. John Shurley

Mr. Shurley welcomed everyone to the meeting.

Mr. Shurley stated that an attendance sheet for Commissioners had been distributed to each Commissioner's seat.

3. <u>Director's Report</u>: Dr. Dan Morrill

- Dr. Morrill reported the following:
- 1) Grier-Rea House. Mr. Robert Bugg, the prospective buyer, has submitted a request to terminate his contract to purchase the Grier-Rea House. This matter will be discussed in executive session later in the meeting.
- **2) Torrence Lytle School, 302 Holbrooks Rd., Huntersville, N.C.** The State Board of Education has ruled not to issue a charter to the prospective buyer of the property. The Projects Committee will meet at 8:30 a.m. on October 9th to discuss how the Commission should proceed.
- MR. ASBURY PRESENTED A MOTION SECONDED BY ROGERS THAT THE MATTER OF ISSUING A REQUEST FOR PROPOSALS TO PROSPECTIVE BUYERS OF THE TORRENCE LYTLE SCHOOL BE REFERRED TO THE PROJECTS COMMITTEE FOR CONSIDERATION AT ITS OCTOBER 9, 2013, MEETING. THE COMMISSION APPROVED THE MOTION WITH MR. SHURLEY RECUSING HIMSELF FROM THE VOTE.
- **3) Dr. George E. Davis House, 301 Campus Street in Charlotte, N.C.** Work on the restoration of the house continues. Mr. Turner reported on the progress to date.
- **4) White Oak Plantation, 7729 Hood Road, Charlotte, N.C.** Mr. Eric Gamble, realtor, is actively marketing the property. The small rental house has been vacated. T. R. Lawing has advised that the house be boarded up because repairs would not be justified in relation to the anticipated rental income. Staff has boarded up the house. The main plantation house continues to be rented.
- **5) Funderburk-Plaxco House, 316 East Matthews St., Matthews, N.C.** The Matthews Town Board will vote on a recommendation from its zoning board on September 9th. If the rezoning is approved, the buyer intends to close on the property in the next few days.
- **6)** Rozzel House, 11647 Rozzelles Ferry Rd., Charlotte, N.C. The tenant house has been vacated and is boarded up. The Projects Committee will continue to review marketing strategies for the property. Staff will be contacting the realtor who successfully sold the McAuley House.
- **7) Former Younts General Store, 316 Main St., Pineville, N.C.** The Town of Pineville is submitting a grant to the Arts and Science Council to develop a business plan for the Civic and Cultural Arts Center of Pineville, the tenants of the building. The Commission will be involved only in an advisory capacity. The listing with the current realtor was extended for one year. The lease on the building will expire this month.
- 8) Former Blankenship Oil and Feed Store, 330 Main St. Pineville. The tenant continues to pay the rent. The building is being marketed. The listing with the current realtor was extended for one year. The lease on the building will expire this month.

- 9) Outen Pottery, 430 Jefferson St., Matthews Arts and Science Council Grant. Staff has edited the final report and will be meeting in the near future with officials of the Town of Matthews to consider how to proceed.
- **10) Siloam Rosenwald School.** The owner has agreed in concept to donate the building and allow it to be moved. Preliminary discussions continue with UNCC officials about the possibility of moving the school building to the campus.
- **11) Violet W. Currie House, 525 North Main St., Davidson, N.C.** The public hearing with the Town Board of Davidson to consider designation of the Currie House will occur on October 15th. The Commission will hold its public hearing on October 14th.

The Commission also approved termination of the contract with Bugg Investments, LLC to purchase the Grier-Rea House, 6701 Providence Rd., Charlotte, N.C.

- **9.** New Business: Ms. Lester suggested that a holiday gathering for the HLC could be scheduled at the Reid House in Matthews. The Commissioners responded favorably to this suggestion. Ms. Lester will check on dates that are available at the house in December.
