Ordinance - Restormel

**Ordinance designating as a Historic Landmark a property known as "Restormel" (listed under Tax Parcel Number 00315130 and including the exterior of the house, the exteriors of all of the outbuildings, and the parcel of land listed under Tax Parcel Number 00315130 in the Mecklenburg County Tax Office, Charlotte, North Carolina as of October 1, 2006). The property is owned by David and Jamie Dunn and is located at 829 Concord Road in Davidson, North Carolina.**

WHEREAS, all of the prerequisites to the adoption of this ordinance prescribed in Chapter 160A, Article 19, as amended, of the General Statutes of North Carolina have been met; and

WHEREAS, the members of the Town Board of Davidson, North Carolina, have taken into full consideration all statements and information presented at a joint public hearing held with the Charlotte-Mecklenburg Historic Landmarks Commission on the 14th day of NOVEMBER, 2006, on the question of designating a property known as Restormel as a historic landmark; and

Ordinance – Restormel

WHEREAS, Restormel is a fine, prominent, distinctive, and (in terms of Davidson) early example of the Colonial Revival Style; and

WHEREAS, Restormel was designed and occupied by Dr. Fraser Hood, who came to Davidson College in 1920 to head its new psychology department during a significant period of expansion for the school; and

WHEREAS, Restormel contains the only known example in Mecklenburg County of a Rustic Revival log building that is a secondary structure of a private residence; and

WHEREAS, the retaining wall on the south elevation of the property facing Concord Road was constructed from some of the foundation stones from the original Chambers Building on the campus of Davidson College, which burned in 1921; and

WHEREAS, the property known as Restormel is owned by David and Jamie Dunn.

NOW, THEREFORE, BE IT ORDAINED by the members of the Town Board of Davidson, North Carolina:

1. That the property known as the “Restormel” (listed under Tax Parcel Number 00315130 and including the exterior of the house, the exteriors of all of the outbuildings, and the parcel of land listed under Tax Parcel Number 00315130 in the Mecklenburg County Tax Office, Charlotte, North Carolina as of October 1, 2006) is hereby designated as a historic landmark pursuant to Chapter 160A, Article 19, as amended, of the General Statutes of North Carolina. The location of said landmark is noted as being situated at 829 Concord Road, Davidson, North Carolina. Exterior features are more completely described in the *Survey and Research Report on Restormel (2006)*.

2. That said exterior is more specifically defined as the historic and structural fabric, especially including all original exterior architectural features and the contours of landscaping.

3. That said designated historic landmark may be materially altered, restored, moved or demolished only following issuance of a Certificate of Appropriateness by the Charlotte-Mecklenburg Historic Landmarks Commission. An application for a Certificate of Appropriateness authorizing the demolition of said landmark may not be denied, except if such landmark is judged to be of State-wide significance by duly authorized officials of the North Carolina Division of Archives and History. However, the effective date of such Certificate may be delayed in accordance with Chapter 160A, Article 19, and amendments thereto, and hereinafter adopted.

4. Nothing in this ordinance shall be construed to prevent or delay ordinary maintenance or repair of any architectural feature in or on said landmark that does not involve a change in design, material or outer appearance thereof, nor to prevent or delay the construction, reconstruction, alteration, restoration, demolition or removal of any such feature when a building inspector or similar official certifies to the Commission that such action is required for the public safety because of an unsafe condition. Nothing herein shall be construed to prevent the owner of the historic landmark from making any use of the historic landmark not prohibited by other statutes, ordinances or regulations. Owners of locally designated historic landmarks are expected to be familiar with and to follow *The Secretary of the Interior's Standards for Rehabilitation and Guidelines for Rehabilitating Historic Buildings*, the guidelines used by the Charlotte-Mecklenburg Historic Landmarks Commission to evaluate proposed alterations or additions.

5. That a suitable sign may be posted indicating that said property has been designated as a historic landmark and containing any other appropriate information. If the owner consents, the sign may be placed on said historic landmark.

6. That the owners of the historic landmark known as Restormel be given notice of this ordinance as required by applicable law and that copies of this ordinance be filed and

indexed in the offices of the Town Clerk, Building Standards Department, Mecklenburg County Register of Deeds, and the Tax Supervisor, as required by applicable law.

7. That the property which is designated as a historic landmark shall be subject to Chapter 160A, Article 19, of the General Statutes of North Carolina as amended, and any amendments to it and any amendments hereinafter adopted.
